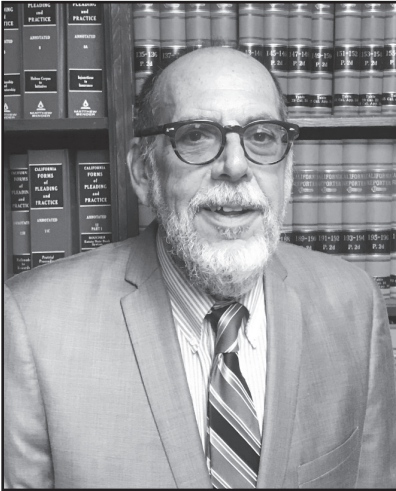

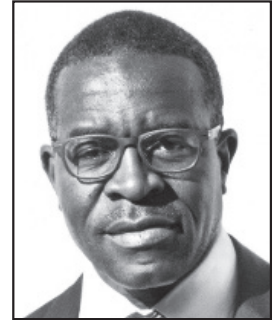

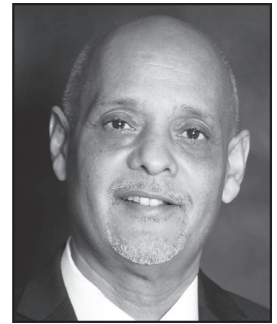

2020 Morton Herbert Service Award  
**ROBERT L. GRACE, JR.**

Robert “Bobby” Grace is currently a Deputy District Attorney for the County of Los Angeles. He is in the hardcore gang unit and currently is the Supervising District Attorney in the Compton Court. He has previously worked in the Family Violence, Major Crimes, and the Conviction Integrity Unit of the Los Angeles County District Attorney’s office. In that new department he was charged with reviewing wrongful conviction claims, many of which would not have been reviewed unless the Loyola Law School’s Project for the Innocent became involved. In its first year, the Conviction Review Unit was successful in obtaining the release of two men who were servicing life sentences for crimes they did not commit. Such units are rare but send a strong statement that the District Attorney’s office is serious about reversing injustices.



***In his own words:***

“I believe that one of the essential missions of the criminal justice system should be to seek truth,” said Grace. “This new position allows me the opportunity to seek truth in a venue that is consistent with the duties of prosecutors.”

***Mr. Grace has been associated with many notable cases including:***

- People v. David Mahler (2008)
- People v. Wayne Taylor (2007)
- People v. Helen Golay & Olga Rutterschmidt (2008)
- People v. Calvin Broadus (1996)
- People v. Chester Turner (2007)

In 2002, The Association of Deputy District Attorneys (“ADDA”) awarded Mr. Grace their “Pursuit of Justice Award” for obtaining murder convictions in the case of People v. Henry Hayes. In 1999, Mr. Grace received the “Outstanding Community Service Award” for securing murder convictions against three Los Angeles gang members for the slaying of a high-school student, Corrie Williams, who was killed while riding a MTA bus home from school.

Mr. Grace is involved in substantial community service outside the practice of law.

He is a member of the Alumni Association Board of Governors of Loyola University where he mentors recent graduates. He knows the next generation of lawyers coming out of Loyola will lead the way towards positive change. “They are doing groundbreaking clinical work for the Los Angeles community, like the Project for the Innocent and Immigrant Justice Clinic. These are important trends in the industry. Students who do this work are motivated and wherever you see passion, you see movement.”

Mr. Grace’s desire to serve further extends outside the courtroom as he is the board chair of the UCLA Black Alumni Association. Every year the UCLA Black Alumni Association, in partnership with the organization We Are Our Brother’s Keeper, raises funds to purchase essentials like soap, toothbrushes, and socks for homeless families.

***In his own words:***

“I found a lot of people are caught up in Criminal Justice because of long-standing social economic issues. One way to help is to provide basic needs. If we can do that, maybe that will be one person who won’t commit a petty theft or steal because their basic needs were met.”

Also, The UCLA Black Alumni Association raises money for scholarships for qualified students. To date they have raised over five million dollars for these deserving young people, paving the way to future success.

*2020 Robert Takasugi Judicial Excellence Award*  
**HONORABLE CHARLAINE F. OLMEDO**



Los Angeles County Superior Court Judge Charlaine Olmedo, the recipient of the Robert Takasugi Judicial Excellence Award, has distinguished herself over an 18 year judicial career with her even-handed and thoroughly reasoned rulings, upbeat personality, and genuine respect displayed towards all parties who appear before her, including defendants accused of committing vicious crimes. It is no coincidence that Judge Olmedo has rarely experienced defendants acting out in court or refusing to leave their County jail cell during trial. Despite a steady diet of murder cases in her 9th floor of the Criminal Courts Building courtroom, cynicism and callousness are not part of her judicial decision-making process, and she succeeds in reducing tensions inherent in high stakes jury trials while creating a level playing field for the trial participants.

Raised in Pacific Palisades and Beverly Hills, the sometimes harsh reality of the criminal justice system struck home at the young age of eight when her father was sent to prison for embezzlement, leading to weekly family prison visits, a profound experience for her that cultivated a sense of empathy and appreciation of human tragedy.

Always a high achiever, she became an attorney at age 23 and a judge at 37. She worked as a Los Angeles Deputy District Attorney from 1989-1994, and as an assistant United States Attorney from 1994 until 2002, when she was appointed to the bench by Governor Gray Davis. She has served as the supervising Judge of the San Fernando Courthouse, where she was credited for cleaning up an unwieldy backlog of cases, and served as the Supervising Judge of the Los Angeles County Superior Court Criminal Department from 2012- 2014. Judge Olmedo is married to a Los Angeles County Sheriff's Department detective, and has two sons, aged 25 and 16. The eldest son was a college baseball star who played several years in the Tampa Bay Rays organization.



*2020 Joseph Rosen Justice Award*

**FRANK P. DUNCAN**

The Criminal Courts Bar Association tonight is bestowing long overdue recognition in presenting the Joseph Rosen Career Achievement to attorney Frank Duncan. Throughout a prominent career that has spanned eight decades, Duncan has distinguished himself as a scrappy trial lawyer with deep knowledge of criminal law and procedure, and as a fiercely devoted advocate for his clients. Well into his 80s Duncan was trying serious felony cases, including murders and attempted murders, displaying a formidable presence in the courtroom, and often obtaining favorable results. Admitted to the State Bar in 1955, Duncan has developed over the years a remarkable rapport with his youthful clients, including rappers and hard core gang members. In the process he overcame a great personal tragedy occurring in 1958, when his wife was murdered by two hitmen hired by Duncan's mother, who was convicted, sentenced to death, and executed in California's gas chamber. Duncan received his undergraduate degree from UC-Santa Barbara, and his law degree from the Hastings College of Law in San Francisco.



## 2020 Jerry Giesler Memorial Award

### KAREN L. GOLDSTEIN



Karen L. Goldstein became a criminal defense trial lawyer because of her strong desire to fight for the underdog and to protect constitutional and human rights. She has been practicing criminal defense exclusively since 2003 and founded her own law firm, the Law Offices of Karen L. Goldstein, in 2007.

Ms. Goldstein focuses her practice on trying complex state and federal jury trials, including child molestation, rape, RICO, drug trafficking, murder, and white collar crimes. In 2019, these trials included a federal RICO/murder trial and a state child molestation case.

The state case was first dismissed in the middle of voir dire, and then on retrial, Ms. Goldstein obtained a hung jury that voted overwhelmingly for not guilty, on all six counts, saving her client from a life sentence.

Ms. Goldstein is well-known within the defense community for tackling difficult, high-stakes cases and is undeterred by the clear challenges her clients face in a modern #metoo era. She is adamant that clients from all socio-economic backgrounds deserve a vigorous defense. Ms. Goldstein is a member of both the State Indigent Criminal Defense Appointment (ICDA) Panel and the Federal Criminal Justice Act (CJA) Panel in Los Angeles where she represents indigent clients who cannot afford to hire a private attorney.

Her law firm motto, “Persistent, Principled, Passionate,” appropriately sums up her approach to criminal defense: apply laser focus, handle every detail meticulously, fight with integrity, and offer relentless advocacy.

Ms. Goldstein sees tremendous value in being a community advocate and volunteering her time both professionally and personally. She currently mentors young female scholars from underserved communities through the nonprofit organization MOSTe (Motivating Our Students Through Experience), an organization dedicated to helping students get into college, many of whom are first-generation college students.

An aspiring lawyer since a young age, Ms. Goldstein was drawn to Georgetown University because it was a diverse, international community known for valuing social justice and service to others. In 1999, she graduated magna cum laude from Georgetown University with a Bachelor of Arts. In 2003, she graduated cum laude from Georgetown University Law Center, with a Juris Doctorate.

Ms. Goldstein has been consistently named as a Southern California Super Lawyer from 2012-2020 and has also been recognized as a Top 100 Trial Lawyer. She is a member of the California and Washington, D.C. Bars and is currently being admitted to the New York State Bar. She is fluent in French and speaks Spanish conversationally.

Ms. Goldstein is thrilled to be the recipient of the Jerry Giesler Memorial Award. This distinction feels particularly significant because she is only the fifth female attorney to be given this acknowledgement in the history of the Criminal Courts Bar Association.



*2020 President's Award*  
**EZEKIEL P. PERLO**

Ezekiel Perlo is a Los Angeles native. He received his undergraduate and law degree from UCLA. When he began practicing law, he practiced personal injury for a short time. After determining the civil practice was not for him, he joined the Public Defender's Office in 1969. It should be noted, that while working at the Public Defender's Office, he was the star of the Public Defender's Office basketball team, where he led the team to two consecutive Lawyer League championships.

Ezekiel retired from the Public Defender's Office in 1983, and thereafter went into private practice. He eventually joined the Indigent Criminal Defense Appointment panel - commonly known as the ICDA - and helped represent indigent people being charged with crimes. Eventually, because of his hard work and successful representation of defendants, Ezekiel was asked to lead the ICDA.

For over 10 years, Ezekiel led the ICDA, until he retired on December 31, 2021. Now, as a retiree, he has more time to enjoy his wife Janice and children, Michael, and Jessica.

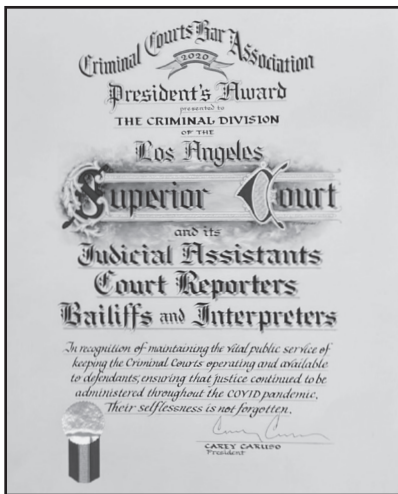

## 2021 President's Award

### THE CRIMINAL DIVISION OF THE LOS ANGELES SUPERIOR COURT AND ITS JUDICIAL ASSISTANTS, COURT REPORTERS, BAILIFFS, AND INTERPRETERS



As the 2021 President of the Criminal Courts Bar Association, I presided over discussions on who should be recognized for our usual awards – the Giesler (trial lawyer of the year), Rosen (lifetime achievement), Mort Herbert (commitment to service), Takasugi (trial judge of the year), and the President's Award, which is a perk of the presidency.

Because of the court shutdown, it soon became apparent that because we were talking about things that occurred in 2020, there wasn't a whole lot to recognize.

The Criminal Court System was on life support. WebEx became the preferred method of appearances for attorneys, in custody defendants might or might not appear due to jail quarantines that were imposed sometimes on the date of the defendant's appearance, no trials, few preliminary hearings, little access to clients, and a lot of fear of the unknown ruled the day.

There was one set of individuals who seemed impervious to all this and that was the Criminal Court System itself.

Every day, throughout the entire year, judges, judicial assistants, bailiffs, court reporters, and interpreters showed up in person to do their jobs. The System, while hobbled, never stopped.

There was only, in reality, one award to give and that was to collectively recognize the judges, judicial assistants, court reporters, bailiffs, and interpreters who assumed the risks to keep the whole thing going.

So congratulations! And thanks to all of them for their contributions to insure we all got through 2020!





2022 *Johnnie Cochran Award*  
**ANGELA M. BERRY**

Angela Berry is an accomplished 31-year criminal defense veteran credited with numerous notable successes, most recently, the Parole Board release recommendation for Sirhan Sirhan. Ms. Berry provided pro bono services to Mr. Sirhan and was able to secure the Board's recommendation after 15 prior denials. Although Governor Newsom rejected the Parole Board's recommendation, Ms. Berry intends to complete this journey and is preparing a writ of habeas corpus; she remains committed to performing whatever legal means are needed to assure the release of her client.



Ms. Berry has consistently provided zealous advocacy with extraordinary results on behalf of her clients. A few recent cases are summarized below but cannot reflect the breadth of defense matters handled by Ms. Berry. One recent victory involved the wife of a Mexican Mafia member charged with Attempt Murder and Conspiracy to Commit Murder, along with various Gun and Drug-related charges. Ms. Berry's client was snared in a 43-defendant prosecution and Ms. Berry first successfully argued bail reduction (3.5 million to \$450,000) and ultimately negotiated dismissal of all charges with prejudice because she was able to persuade the prosecution that her client was merely married to the mob.

Other recent successes include a client charged with Attempted Rape, Assault to Commit Rape, Criminal Threats, and False Imprisonment with 3 prior convictions for Rape and a slew of prior 1108 conduct. Ms. Berry's superior trial skills resulted in an acquitted of all sex charges and criminal threats - her client only convicted on a lesser charge of false imprisonment. Another matter involved a client charged with one count Child Molestation 288(a) and Ms. Berry secured an acquittal at jury trial. And yet another case, a client faced a 3-strikes Home Invasion Armed Robbery - all charges were dismissed with prejudice after preliminary hearing following Ms. Berry's extensive pre-trial investigation and tenacious persistence that exposed the alleged victim's lies.

Ms. Berry has also enjoyed appellate and habeas petition successes. On appeal she recently received reversal on 4 cases, including conviction reversal on trial court error in admitting certain prejudicial evidence, and conviction reversal on trial court error in denying motion to suppress evidence in violation of the Fourth Amendment. Ms. Berry's recent habeas work includes finding a due process violation and the court's reversal of the prison Board's denial of parole on a life sentence.

Ms. Berry's history of exceptional advocacy cannot be detailed in this brief summary, but so many hard won victories on behalf of so many accused and convicted individuals merits the enduring recognition and honor of the Johnnie L. Cochran Award.



## 2022 *President's Award*

### FELIPE INIGUEZ PLASCENCIA (*Posthumous Recognition*)



My name is Jesse A. Arana and I am the 2022 President of the Los Angeles County Criminal Courts Bar Association. I am honored to present the 2022 President's Award, posthumously, to the great Felipe Plascencia. I am presenting my President's Award to Mr. Plascencia for all the outstanding work he has done for our legal community, especially his mentorship.

Throughout my career I have been fortunate enough to have fantastic mentors to guide me in my path from undergrad, to law school, to being a prosecutor and to eventually opening my own practice as a criminal defense attorney. Felipe Plascencia is one of the greatest mentors I was lucky enough to help guide me.

I first met Mr. Plascencia in 2015 when I just opened my law practice. I was blown away by his authenticity, demeanor, swag, charm, success, and, most importantly, his willingness to help anyone who asked for help. I was initially hesitant to ask him for any advice and I think Mr. Plascencia recognized that. He took it on his own to introduce himself to me and give me pointers regarding the world of DUI defense. At every opportunity, I would sit in Mr. Plascencia's jury trials. It was even a spectacle to see Mr. Plascencia plea negotiate with a prosecutor. I knew Mr. Plascencia was a DUI Warrior but was unaware he was a DUI Jedi Master. He knew how to explain, using simple language which at times, included toy cars, to the jury why the evidence failed to establish beyond a reasonable doubt that his client was guilty of an alleged DUI offense. Perhaps it was just my imagination, but anytime I noticed a prosecutor saw Mr. Plascencia enter a department I noticed the prosecutor display a slight twitch of excitement and nerves.

Throughout my years of getting to know Mr. Plascencia his advice to me graduated from mere DUI defense legal strategy to how to be a successful business owner, to the importance of giving back to one's community, to, eventually, more importantly on how to be a great husband, father and overall human being. Mr. Plascencia is, unfortunately, no longer with us. However, his legacy continues to live on through his wife, family and every lawyer, including myself, that he has mentored. 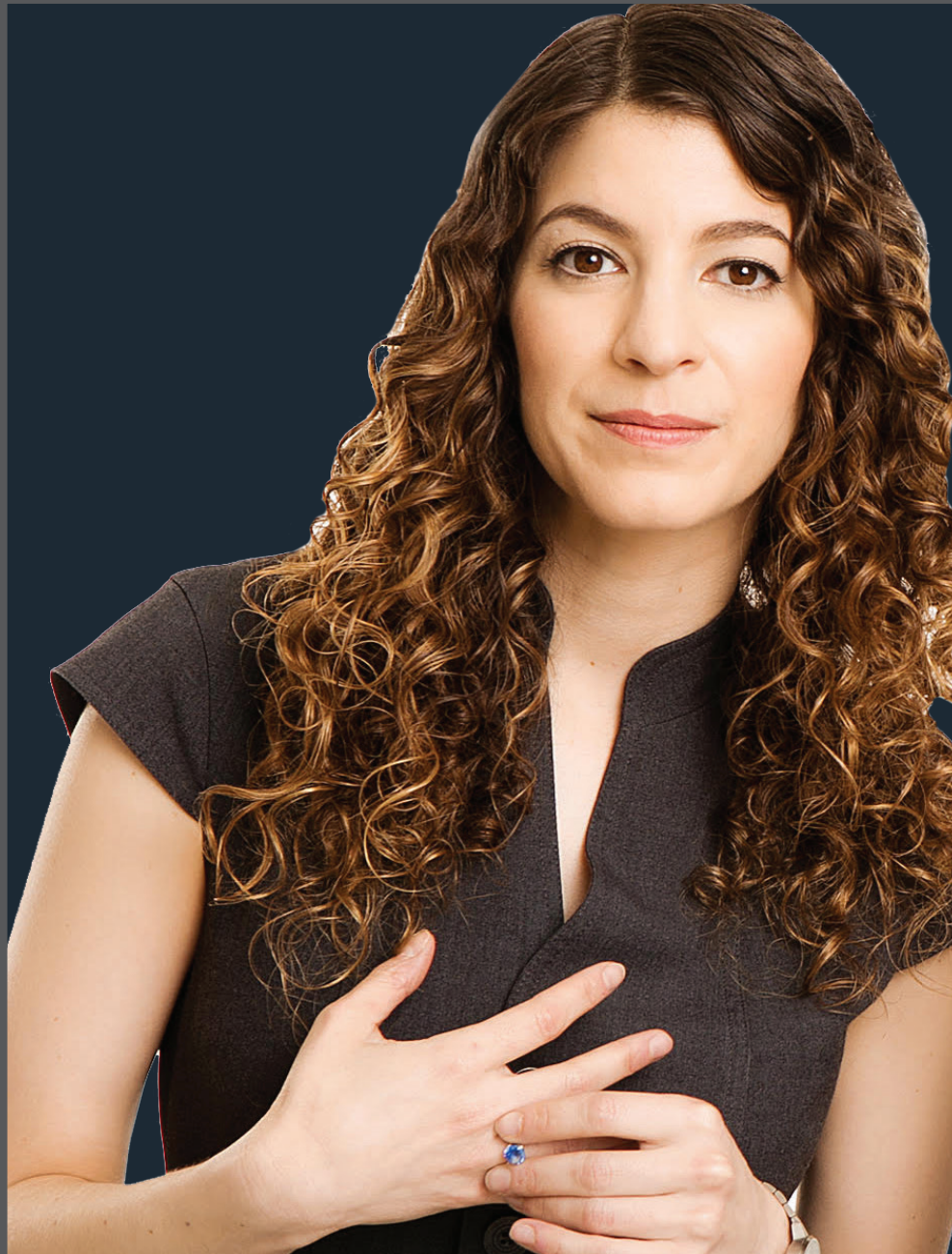

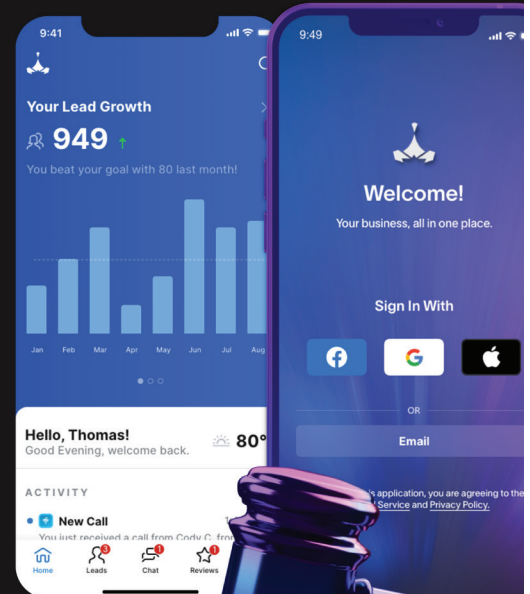

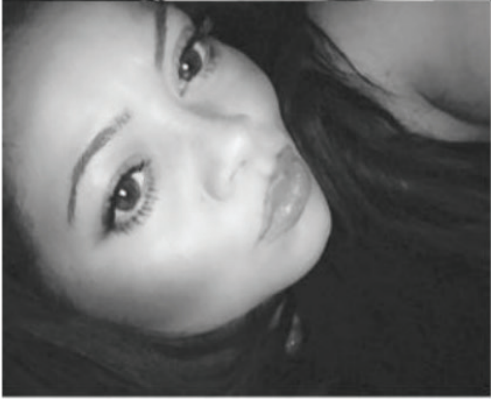
